We would like to bring in your kind notice a few issues related to the UG Psychology Honours syllabus that require your urgent intervention.

I BA Ist Year (UGC CBCS 2018-2019 Onwards): As per the approved syllabus by the university BOS and the Academic Council, students are required to do 7 DSC and 2 SEC courses.


However in the meeting with the COE, in the presence of Chairperson Psychology Department HPU, it was pointed out to one of our faculty members that students were required to do only 4 DSC, in addition to 2 GE and 2 AECC courses.

II UGC CBCS 2016-17 onwards: As per the approved syllabus by the university BOS and Academic Council, students were required to do GE Courses of Psychology subject only.

This has been categorically stated by the Chairperson, Psychology Dept. HPU vide letter No 10-11/2016-Psy-HPU-217 dated 7-10-2016. We had repeatedly sought clarifications in this regard in 2017 also from the Chairperson Psychology Dept HPU.

However in the meeting with the COE in the presence of Chairperson Psychology Department HPU, it was pointed out that the GE courses should be of some other discipline.

Since the students were being taught as per the duly approved syllabus till now , it will highly inconvenience and harass them (Specially VI Semester students) if any changes are imposed at this late stage. Their future career and job prospects would be adversely affected by any untoward demands for GE courses when examinations are almost due.


However in the meeting with the COE, in the presence of Chairperson Psychology Department HPU, it was pointed out to one of our faculty members that students were required to do only 4 DSC, in addition to 2 GE and 2 AECC courses.

II UGC CBCS 2016-17 onwards: As per the approved syllabus by the university BOS and Academic Council, students were required to do GE Courses of Psychology subject only.

This has been categorically stated by the Chairperson, Psychology Dept. HPU vide letter No. 10-11 2016-Psy-HPU-217 dated 7-10-2016. We had repeatedly sought clarifications in this regard in 2017 also from the Chairperson Psychology Dept. HPU

Proceedings of the Meeting of (UG) Board of Studies, Department of Psychology.

ITEM NO. 1(A): To place before the issues of UGC CBCS, Psychology –Ist year (Hons) raised by the Principal St. Bede's College Shimla vide reference No. SBC/HPU/12/764/2019 dated 13.02.2019.

RESOLUTION: Board of Studies in the subject of Psychology examined the issues minutely and reached at a consensus that UGC Template for Psychology Honours should be followed strictly in B.A. Psychology Honours. In First Year, students have to do 4 DSC Psychology, 2 AECC compulsory courses and 2 GE of other disciplines; Four DSC Courses namely Introduction to Psychology (BAPSYCH101 Th/Pr); Psychology of Individual Differences (BAPSYCH 102 Th); Psychological Research (BAPSYCH 103 Th) and Introduction to Social Psychology (BAPSYCH104 Th).

Further, the Members of Board of Studies resolved that the students of other disciplines have to study two GE Courses selected from BA Pass Course Syllabus namely Foundation of Psychology (BAPSYCA101 Th) as GE-1 and Introduction to Social Psychology (BAPSYCA102 Th) as GE-2.

ITEM NO 1(B). To place before the BOS the issue of GE subject of UGC CBCS 2016-2017 Psychology Honours 4<sup>th</sup> and 6<sup>th</sup> Semesters as raised by the Principal St. Bedes Shimla vide reference No. SBC/HPU/12/764/2019 dated 13.02.2019.

**RESOLUTION:** The Board of Studies resolved that the students of Psychology in the sessions 2016-17, 2017-18 and 2018-19 who have been taught GE in the very subject (Psychology)in place of interdisciplinary subjects may be allowed / considered to earn the credits.

ITEM NO-2: To revise/improve the UGCBCS Psychology Honours (BA- II Year and BA- IIIrd Year) as per UGC Template

RESOLUTION: The Board of Study resolved that the UGC CBCS Psychology Honours (BA- II Year) should be adopted as per UGC Template. More appropriately, students have to study six DSC Courses namely Bio Psychology (BAPSYCH205 Th); Statistical Methods for Psychological Research-1(BAPSYCH206 Th); Developmental Psychology BAPSYCH207 Th); Understanding Psychological Disorders (BAPSYCH208 Th/Pr); Applied Social Psychology (BAPSYCH209 Th) and Counseling Psychology (BAPSYCH210 Th). Further, the students have to study 2 SEC: SEC 1- Stress Management (BAPSYCH211 Th) and SEC-2 Effective Decision Making (BAPSYCH212 Th). Moreover, students have to study 2 GE of other disciplines in B.A. IInd year also.

Further, the Members of Board of Study decided that the Honour students of other subjects have to study two GE Courses selected from BA Pass Course Syllabus namely Psychopathology (BAPSYCA203 Th/Pr) as GE-2 and Statistical Methods (BAPSYCA204 Th) as GE-2 in B.A. IInd year also The Board of Study decided that in UGC CBCS Psychology Honours (BA- IIIrd Year), the students have to study 4 DSC Courses and 4 DSC Courses are: 1. Health Psychology (BAPSYCH 13 Th); 2. Organizational Behavior (BAPSYCH 14 Th); 3. Understanding and Dealing with Psychological Disorders (BAPSYCH 15 Th) and 4. Project (BAPSYCH 16) 4 DSE Courses are: 1. Psychology at Work (BAPSYCH317 Th)
2. Intergroup Relations (BAPSYCH318 Th) 3. Emotional Intelligence (BAPSYCH319 Th.) and 4. Community Psychology (BAPSYCH320 Th) The Board of study authorized the Chairperson to amend the syllabus (if required) in future. 
